Important Requirements by location

Las Vegas: To sell merchandise at this location you must have all applicable city, county, state or federal licenses and the right to vend pursuant to the terms of a permit issued pursuant to chapter 8.10 or 8.11 of the Henderson Municipal Code, subject to the terms of said permit.

San Diego: The city requires all vendors to provide event liability insurance. 1 million occurrence and 2 million aggregate. The certificate should show the City of San Diego as additionally insured and be sent to Alvin Nguyen: AlvinN@sandiego.gov.

Chino: The park requires a fee of \$25 for commercial vendors and \$50 for food vendors. This fee is assessed IN ADDITION to the fee assessed by J6 Events. The park also assesses a \$10 per vehicle parking fee at the gate, payable in cash ONLY.

Terms of Contract

J6 Events LLC reserves the right to prohibit the sale or display of certain items for any reason whatsoever. This policy is in place to prevent the distribution or sale of inappropriate items or activity that conflict with the rules of the venue. Any conflicts will be resolved in favor of the venue in every instance.

Vendor will hold J6 Events LLC and venue harmless of all liabilities as a result of vendor's activities or representations at the event. J6 Events is not responsible for any lost or stolen merchandise, and does not accept liabilities for the behavior of event participants, employees or volunteers.
